B. STUDY SESSION

(1) Fiscal Stability Plan
Referred to the Board by:
Paul Ziegler, Assistant Superintendent of Business Services

Ziegler addressed the Board and discussed the need for a Fiscal Stability Plan and the ability to act on it. The Board is provided a copy of a letter from Lynette Kerr with the Humboldt County Office of Education (HCOE), dated January 31, 2017. Ziegler notes the District needs to take this matter seriously and put together a plan that can be implemented in order to reduce the structural deficit and bring the District into a balanced budget.

Van Vleck addressed the Board and notes the CSEA ratification is on the Agenda for consideration and approval during the regular meeting on February 2, 2017. The Board will need to decide if they are willing to make the necessary cuts in order to afford the tentative agreement with CSEA. No decisions on specific cuts will be made, only a determination if the Board wants to make cuts to afford the agreement. The final determination regarding the Fiscal Stability Plan is an open session conversation. This matter will be moved to closed session tonight, as the conversation directly relates to the Board's ratification of the CSEA agreement.

N. PUBLIC COMMENT ON NON-AGENDA ITEMS

David Demant addressed the Board regarding the School Climate Grant. He recently met with Michael Davies-Hughes and Kristin Sobilo regarding the grant. He is excited about the possibility of a "hub" for students but is concerned about the timeframe as these are big projects. He believes the projects are scheduled for "tomorrow" instead of "now" and is worried about the impact on the students and staff. There needs to be an "in the meantime" plan, even if it is not the final solution. He receives many calls relating to issues at the sites. The District needs more "boots on the ground" and he suggests that the Board should consider hiring a Student Services Coordinator to help free up the people that need to be focusing on the students. Demant appreciates the work being done by the Board.

Joe Bonomini addressed the Board regarding safety issues at EHS. He is concerned that students are not traveling in buses and instead are being transported in personal vehicles. He notes concern about various situations, including when he was unable to speak with EHS administrators about an unsafe situation involving the volleyball team. He is concerned with parents being involved in coaching activities when they are not qualified. This is not fair to the programs or to EHS. He also notes other concerns and specific issues with the

administrative team and the AD. He would like to work with administrators to resolve these issues to help bring EHS back to where it needs to be.

Van Vleck addressed the Board regarding the long process of changing the election areas from at-large to individual trustee areas. This change is being made due changes in the law. The final step of this process is to request a waiver through the California State Board of Education. The District would like to ask the California Department of California to waive the election requirement for this change to the election area, which is a common request. As part of the process, the District has had the intent to request the waiver reviewed by the District English Learner Advisory (DELAC) and no objections have been received. The District has also reached out to the bargaining groups. CSEA has indicated it is neutral and ETA has no objection.

Board President Ollivier indicates the purpose of this is to properly represent the constituency.

Q. DISCUSSION

(30) Pre-School Program Overview
Referred to the Board by:
Laurie Alexander, Director of Student Services

Laurie Alexander introduced Maikken Bass, the Director of Winzler Children's Center (WCC). Bass provided an overview to the Board on enrollment and other student demographics. She also reviewed the current programs at Winzler which include a Part Day School Year State Preschool, Extended Day Full Year State Preschool, Special Day Preschool Austism Class and a Preschool Speech Program. WCC currently has over 18 employees. The biggest update at WCC this year is the Autism Special Day class, which provides early intervention to students and eventually will help students transition to regular classrooms. Bass also discussed the updates at the Winzler including the bond improvement list and areas they are focusing on based on the California Department of Education State Preschool review. WCC focuses on the strategic goals during program implementation and curriculum framework. The plans of goals of WCC include preschool connectivity, integration of special education, preschool/TK/K continuum and collaboration, increasing academic sophistication, financial stability and continuing to grow the program.

(31) IRS Mileage and Per Diem Rates

Mileage and per diem rates have changed for 2017 and is now 53.5 cents per mile. There has been a slight decrease in the reimbursement rate for the use of a private car. The rate for travel meals and incidentals remains the same.

(32) Annual Report on Effectiveness of Activities Funded by Title I
Referred to the Board by:
Michael Davies-Hughes, Assistant Superintendent Educational Services

Davies-Hughes presented to the Board on "Title I Funding at ECS — Effectiveness of Activities 2015-16." ECS currently has six Title I schools. Schools are identified to receive Title I funding based on students that receive free and reduced lunches. Schools that have 35% of students receiving free or reduced lunch receive Title I funding. ECS schools currently receiving Title I funding including Alice Birney, Grant, Lafayette, Washington, Winship and Zane. Parents of students attending a schools receiving Title I funds have the right to ask for meetings and trainings, review the result of annual parent involvement effectiveness surveys, make suggestions for Title I funding, review the school's achievement data and parent involvement plan, etc. There are also requirements regarding curriculum and assessments for schools using Title I funds. Title I funds are also used to fund various positions, including library techs, student service coordinators, intervention teachers, instructional coaches, administrative assistants and homeless education coordinators.

(33) Local Control Accountability Plan Update

Davies-Hughes provided a update to the Board on where the District is at on the Local Control Accountability Plan Update (LCAP). The writing team includes Bath Holcomb, Jennifer Johnson, Jeannie Wilhelm, Brad Albee, Melissa Cooke and Michael Davies-Hughes. The LCAP will be brought to the Board in two sections as well as at a public hearing later in the year. There have been changes this year to the evaluation rubrics and the District is working on getting familiar with these changes.

(34) Report on Eureka City Schools Transportation Department Referred to the Board by:
Paul Ziegler, Assistant Superintendent of Business Services

Paul Ziegler introduced Dan Pires, the Director of Transportation. Pires addressed the Board and provided a transportation update on staffing, the bus fleet (11 larges buses total, 7 used every day and 4 small buses, 3 used daily), number of students utilizing specialized transportation, etc. A "snap shot in a day in transportation" was shown to the Board, showing what bus picks up at different sites, the number of students picked up, the total miles driven, etc. The Transportation Department will be looking into the possibility of applying for a bus grant, most likely requesting a high-tech diesel or compressed natural gas bus. The grant is for \$165,000, which is almost full payment on the bus. Ziegler notes ECS' appreciation for the great work done by Dan Pires and his team in the Transportation Department.

(35) Revision of Assistant Supervisor of Food Services Job Description and Placement on the Classified Management Salary Schedule Referred to the Board by:

Laura Chase, the Director of Food Services, has asked for an assistant to work on special projects in food services. The Governing Board is asked to discuss the revision of the Assistant Supervisor of Food Services job description and placement on the Classified Management Salary Schedule.
